

TERMS OF AGREEMENT

This contract is between 753289 ONTARIO LTD OA Burt's Greenhouses and the "customer" for storage.

1. The storage provided by this agreement shall be for use of SPACE ONLY and at the sole risk of the customer. Customer hereby releases 753289 ONTARIO LTD OA Burt's Greenhouses of all liability for theft or damage of any kind to the items, contents, gear, or equipment and any other property of customer whatsoever, whether or not such loss or damage shall have been caused by the fault or negligence of 753289 ONTARIO LTD OA Burt's Greenhouses or any of 753289 ONTARIO LTD OA Burt's Greenhouses employees, agents, licensees or invitees.
2. 753289 ONTARIO LTD OA Burt's Greenhouses shall not be responsible for injuries to persons or property occurring on any part of the premises or for any reason whether herein specifically stated or not.
3. Customer agrees to all terms and regulations as set forth in this agreement. Failure by customer to comply with the terms and regulations as stated will entitle 753289 ONTARIO LTD OA Burt's Greenhouses to terminate and cancel this agreement with no refund.
4. Customer will provide insurance for loss or damage to the items stored and holds 753289 ONTARIO LTD OA Burt's Greenhouses harmless from subrogation claims of his/her insurance company.
5. Dealer reserves the right to move the items to any other storage space as 753289 ONTARIO LTD OA Burt's Greenhouses may find necessary.
6. This agreement shall be valid from time items are left in 753289 ONTARIO LTD OA Burt's Greenhouses possession and such time that items are removed from storage and off of 753289 ONTARIO LTD OA Burt's Greenhouses property. Either party may terminate this agreement by giving other party ten (10) days written notice by certified mail. In the event the customer terminates prior to the expiration of the storage period or in the event 753289 ONTARIO LTD OA Burt's Greenhouses terminates due to default of customer in the performance of the terms and conditions of this agreement, any storage fee paid by the customer shall be retained by 753289 ONTARIO LTD OA Burt's Greenhouses and shall not be refunded or prorated. Upon termination of the storage agreement, customer shall promptly remove the item from the premises.
7. A two weeks' notice is required for removal of items from storage. Items not removed by May 1 will be charged storage prorated to the date of the actual removal. Winter storage terminates on April 30 of the current year. Summer storage begins May 1.
8. In the event the customer shall change customer's place of residence as set forth in the storage agreement, customer shall give 753289 ONTARIO LTD OA Burt's Greenhouses written notice of any change within ten (10) days of the change, specifying customer's current residence and telephone number.

9. All deposits and storage fees are nonrefundable. Contract rates are subject to seasonal changes and yearly increases.

10. Payment is to be made in full at the beginning of the term (annual) return required.

The customer agrees to all conditions of this contract and authorizes 753289 ONTARIO LTD OA Burt's Greenhouses to perform services.
